ABOUT THE PROGRAM

The Center for American Law Studies at the Faculty of Law and Administration of the University of Warsaw was established twenty eight years ago and is highly valued and recognized by its participants and by law firms. Thus far over 2200 students have graduated from the program of the Center and many of them have continued their studies in the United States in various LL.M programs. The program is sponsored by two prestigious partner Universities from Atlanta – Emory School of Law and Georgia State University College of Law.

During the two semester program, students take part in two week modules with a total of 160 hours of interactive lectures in English on selected topics in American law, e.g. constitutional law, torts, contract law, criminal procedure, business organizations, and legal writing.

THE CLASS FORMAT

All classes in the Center are planned to be in person. Classes will be held at the University of Warsaw campus in Collegium Iuridicum II at Lipowa 4. Students who live and study outside of Warsaw will be able to participate in classes online.

WHO CAN PARTICIPATE?

The Center for American Law Studies is designed for law students of the third, fourth and fifth year, for students of other disciplines who have an interest in American law and legal culture, and for law graduates.

COURSE OF STUDY

During the academic year 2026-27 the Center will offer eight two week courses. The courses are specially designed and selected to give students a better understanding of the common law system and unique issues of the American legal system. The classes within the two week modules will be held five days a week. The first course in the program will start by mid-October. Before each module participants will receive materials for the class in an electronic version. Each module will conclude with a written examination. After successful completion of the two semester course of study, students will receive 12 ECTS and all participants will be awarded a certificate of completion issued by the three partner universities.



RECRUITMENT

All applicants should timely submit the following documents:

- » a completed application form together with a recent photo

- » a cover letter addressed to the director of the program with an explanation of the applicant's interest in participating in the program and career goals
- » a curriculum vitae
- » a transcript of grades from previous years of study (students) or scan of the diploma (graduates)



LANGUAGE PROFICIENCY

All applicants are encouraged to submit any evidence of their proficiency in English such as: copy of a diploma from a foreign school in an English-speaking country, copy of a diploma from schools specializing in English language, or a copy of the results of any English proficiency exam (for example: FCE, TOEFL). The lack of such evidence will not exclude an applicant from participation in the program. We may contact some applicants by phone to evaluate their proficiency in English.

DEADLINE FOR SUBMISSION OF DOCUMENTS/REGISTRATION

Applicants must submit all required documents through the University of Warsaw IRK system (Internetowa Rejestracja Kandydatów) **by 15 July 2026.**

TUITION

FOR THE TWO SEMESTER PROGRAM IN 2026/27

University of Warsaw Students – 4.000 PLN

Students from other universities – 5.500 PLN

General tuition for graduates – 8.000 PLN

Legal trainees (aplikanci) with discount 10% - 7.200 PLN

Attorneys, legal counselors, judges, notaries with discount of 5 % - 7.600 PLN

Tuition shall be paid by **September 30, 2026**. Participants may request to pay the tuition in two equal installments. To do so the students must submit a short justification of their request to the Director of the Program at: cpa@wpia.uw.edu.pl. Those applicants who submit documents on or before **May 30, 2026** will take advantage of the early bird discount in the amount of 250 PLN.
